#### **PERSONAL EXPERIENCE**

As the Director of TPD's Local Government Services Group, Mr. Richardson is responsible for the management of all of TPD's Municipal Accounts, Construction Services, and Traffic Signal Designs. In addition, he has been responsible for the preparation of highway design plans, preparation of signal design plans for individual intersections, as well as coordinated and closed loop signal systems.

He has conducted or managed over 1,000 signal and intersection designs, traffic impact studies, preliminary designs, and parking studies in PennDOT Districts 2-0, 3-0, 4-0, 5-0, 6-0, and 8-0 as well as in New Jersey and Delaware for a variety of projects. He has served as an expert witness for over 500 of these projects.

He continues to serve as the Municipal Traffic Engineer in two municipalities, where he is responsible for review of internal circulation for pedestrian/vehicular safety studies and traffic/road improvements to designs associated with land development applications. He has also prepared expert witness reports for over 20 accident cases. Mr. Richardson also has extensive experience in the preparation of noise and air quality studies. These studies include the monitoring, modeling and mitigation of noise and air quality impacts for a variety of state, highway, commercial, office, residential, institutional, industrial, hazardous waste disposal and Federal projects in NJ, DE, and PA. The improvement plans called for an additional southbound through lane along the entire ½ mile plus of site frontage on Route 252. Combined with the thirteen signal closed loop system proposed with this project, this alternative enabled the Township to maintain the signalized access where they wanted it and enabled PennDOT to be assured that queues from one signal would not extend into the next. It also enabled the developer to receive project approvals thirteen years after he started the project.

# **East Norriton Crossing Shopping Center**

East Norriton Township, Montgomery County, PA

Responsible for the preparation of highway design plans for the Highway Occupancy Permit application to PennDOT for three site driveways accessing Route 202 and Germantown Pike. This project involved extensive coordination with the PennDOT 6-0 Traffic Unit and Project Management, Montgomery County, and the Township. The improvement plans called for the installation of a new traffic signal at the site drive intersection with Germantown Pike which will be interconnected with four existing signals along the corridor. Mr. Richardson's excellent rapport with the Township, County, and PennDOT Traffic Unit helped to expedite the approval process with final approval being granted two months ahead of the original project schedule.

# Warrington Crossing Shopping Center

Warrington Township, Bucks County, PA

Responsible for the preparation of highway design plans for the Highway Occupancy Permit application to PennDOT for three site driveways accessing Route 611 and County Line Road. This project involved extensive coordination with the PennDOT 6-0 Traffic Unit and Project Management, and the Township. The improvement plans called for the installation of two new traffic signals at the site drive intersections with Route 611 and County Line Road, respectively. Mr. Richardson's expertise in the area of HOP applications and his close working relationship with PennDOT allowed for the recommended road improvements for this project to be coordinated with a scheduled PennDOT improvement project. In addition, close coordination with PennDOT expedited the approval process by two months.

#### Ridley Shopping Center

Responsible for the preparation of highway design plans for the Highway Occupancy Permit application to PennDOT for six site driveways accessing MacDade Boulevard and Morton Avenue. # Montgomery County Traffic Signal Equipment Upgrade Project - Phase II

Montgomery County, PA

Redesigned 29 Traffic Signals within Montgomery County in Metric Units. Job encompassed complete survey of each intersection, categorical exclusion evaluation, public and private utility coordination, right of way investigation, and all related calculations and analyses related to traffic signal design. Synchronization between signals in some municipalities will be completed as needed.

# Lancaster Avenue (S.R. 0030) Closed Loop System Design

Montgomery County, PA

Project entailed synchronizing 23 traffic signals along Lancaster Avenue within Lower Merion Township. New traffic signal permit plans were prepared for each intersection in both English and Metric Units. An alternative analysis was completed to compare all closed loop system technologies (new conduit and trenching, overhead wiring, wiring within existing conduit, telephone interconnect, or spread spectrum radio communication). Recommendations were made to upgrade all 23 intersections as part of the project. Optimization of phasing and timings were also investigated.

# Paoli Shopping Center Closed Loop System Design

Two new traffic signals were designed for the Paoli Shopping Center. The two signals were interconnected with 7 existing signals and all were incorporated into a new closed loop signal
