- 1. Call to Order:** President J. Connors called the meeting to order at 7:08 PM.
- 2. Pledge of Allegiance:** Mayor G. Lerman led everyone present in the Pledge of Allegiance.

**Councilor D. Pancoe** asked about Drop Box. Mgr. G. Locke confirmed Share Point will be used going forward starting in February.

Vice President C. Soltysiak mentioned the next Fire Commission meeting will be held on February 14<sup>th</sup> which is also Mgr. G. Locke's birthday.

Councilor D. Pancoe also asked about two dates: one being October 31<sup>st</sup> for the Zoning Hearing Board. Mgr. G. Locke mentioned emailing them since they don't always have a meeting. Meetings are based on whether there are hearings. Still awaiting an answer whether they can reschedule the one on Halloween to another night. In addition, the Fire Commission meeting date is being adjusted to not be on the first Day of Passover.

- Sgt. Frank Ryan served 30 years in the Borough, and unfortunately passed away this past Monday.
- An annual report was provided in Drop Box; some statistics were described.
- We were able to recruit enough crossing guards to cover all posts this school year.
- There is still an increase in thefts, but the biggest issue is these vehicles are unlocked.
- Accidents were down in numbers from 2023.
- 962 hours of training for the officers last year.
- Municipalities who provided their parking ordinances were also provided in Drop Box.
- Jenkintown PD participated in an event that supported an officer from Scranton who was shot in the head twice. He has a good prognosis for recovery.
