MINUTES

- 1. Call to Order: President J. Connors called the meeting to order at 7:14 PM.
- 2. Pledge of Allegiance: Mayor Lerman led those present in the Pledge of Allegiance.

Dan Gantz of 312 Rodman Ave He about the cost to the Borough to fulfill Right To Know Requests. President J. Connors answered. He also inquired about obtaining statistics for traffic citations. - 8. Engineer's Report: Khal Hassan, Pennoni gave the following updates:
 - Cedar Stret Stormwater Project Bid advertised
 - Continuing to provide construction inspection services at 93 York Road and 821 Homestead
 - Waiting for 2040 Grant for Runnymede/Walnut (01:00:12) Councilor D. Pancoe asked how will the work being done at 93 Old York Road impact the Stormwater Project? Engineer K. Hassan explained. Additional discussion between Engineer K. Hassan, Councilors D. Pancoe, A. Khalil, and D. Ballard.
- 9. Public Works' Department Report: Mgr. G. Locke gave updates when presenting his report.
- **10. Solicitor's Report:** Solicitor P. Hitchens gave the following update:
 - His office continues to provide legal services on an as needed and as requested basis.
- **11. Mayor's Report:** No Report as Mayor G. Lerman was not present.
- **12. Police Chief's Report:** Chief of Police T. Scott gave the following updates:
 - We received \$110,000.00 from PCCD Grant, awaiting additional \$23,000.00
 - 3304 should be returned by the end of the week.
 - The new patrol car should be delivered soon. Three weeks for upfit; middle to end of June.
 - EMS week this week
 - Police week was last week
 - National Memorial new names were added including the Temple Police Office, another from Philadelphia and a few of the State Police Officers.

Councilor D. Pancoe thanked Chief for the email blast reminding folks about the increased Parking Enforcement taking place.

- **13. Manager's Report:** Borough Manager G. Locke gave the following updates:
 - The PSAB has released a list of available funding and we are evaluating he opportunities that may assist the Borough with our needs.
 - The Borough is working to complete the interview and hiring process for Public Works and a Finance Manager. Interviews begin tomorrow.
 - We are closing out our DCED grant that we received \$30,000 for new recycling bins and trash cans. Theres \$4,000.00 of unexpected funds, so we requested a 60-day extension so we can order additional trash cans and recycling bins.
 - The Cedar to Walnut Flood Mitigation Project grant has been advertised for public bid.
 - The paving project has been prepared for advertisement but since PennDOT is having issues with the Penn Bid application.
 - The Borough has been researching the cost of the feasibility of providing microphone and a speaker system for public meetings.

Chief T. Scott mentioned he and the traffic engineer were looking into an additional stop sign at Cedar and Shoemaker. At the request of Councilor A. MacHaffie, Chief T. Scott explained why parking in the direction of flow of traffic is being emphasized.
